Inhalation

Special Protective Equipment and Precautions for Fire-fighters

SECTION 6. ACCIDENTAL RELEASE MEASURES

Methods and Materials for Containment and Cleaning Up

Small spills or leaks: stop or reduce leak if safe to do so. Contain and soak up spill with absorbent that does not react with spilled product. Cover the spill surface with the appropriate type of foam to reduce the release of vapour. Place used absorbent into suitable, covered, labelled containers for disposal. Contaminated absorbent poses the same hazard as the spilled product. Large spills or leaks: dike spilled product to prevent runoff. Knock down vapour with fog or fine water spray. Do not direct water at spill or source. Remove or recover liquid using pumps or vacuum equipment. Flush spill area. Dike and recover contaminated water for appropriate disposal.
